



“\$1,000 LABOR DAY WEEKEND DRAWINGS”
OFFICIAL RULES
(Updated 08/26/10)

- 1. Eligibility:** This drawing is open to all active members of the Finger Lakes Gaming & Racetrack Player Extras Club, who are 18 years old or older, and abide by the rules and regulations of the Player Extras Club. Employees of Finger Lakes Gaming & Racetrack; its subsidiaries and affiliates; people key licensed by the New York State Division of the Lottery; people licensed by the NY State Racing & Wagering Board as on-the-grounds employees; vendors directly associated with this contest, their subsidiaries, affiliates and agencies; and any immediate family members residing in the same household of any of the foregoing individuals are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, consultant, officer; or employee of a contractor, subcontractor, licensee, registrant or consultant, that is directly involved in the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. Members may only receive one entry unless specified on their mystery barcode mailer. Members must play with their Player Extras Card inserted into any video gaming machine each day to be eligible for that day's drawing. Once a drawing is complete Casino Market Place will be zeroed out for the next day's entries. No duplicates, reproductions, or facsimiles will be accepted.
- 5. \$1,000 Prizes:** Three (3) winners will each receive \$1000; one per day of the promotion period.

6. **\$1,000 Prize Drawing:** The prize drawing will be held prior to opening on the next business day and the winner will be notified upon verification. Winner need not be present for the drawing to win. Winner is responsible for all income and sales taxes.

The drawing will be conducted using the Electronic Quickdraw module of the Casino Marketplace player tracking system. All eligible entries are placed into a pool on the date of the drawing, and one name will be randomly selected via the Quickdraw module. A final report illustrating all activity with the Electronic Quickdraw will be printed and kept on file in-house.
