



**“CALENDAR CASH GIVEAWAY”
OFFICIAL RULES
(Updated 12/28/09)**

- 1. Eligibility:** This drawing is open to all active members of the Finger Lakes Gaming & Racetrack Player Extras Club, who are 18 years old or older, and who abide by the rules and regulations of the Player Extras Club. Employees of Finger Lakes Gaming & Racetrack; its subsidiaries and affiliates; people keylicensed by the New York State Division of the Lottery; people licensed by the NY State Racing & Wagering Board as on-the-grounds employees; vendors directly associated with this contest, their subsidiaries, affiliates and agencies; and any immediate family members residing in the same household of any of the foregoing individuals are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, consultant, officer; or employee of a contractor, subcontractor, licensee, registrant, or consultant, that is directly involved in the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. - 3. Drawing Period:** Player Extras Members are encouraged to keep their monthly events calendar which is mailed to them each month and bring it to Finger Lakes Gaming & Racetrack on the last day of that month, prior to 9 pm, for a chance to win up to \$2,010 beginning January 1, 2010.

Method of Entry:** Members may bring their mailed monthly events calendar to the Player Extras Club on the last day of that month, prior to 9 pm, to receive an official entry ticket into the \$1,500 cash drawing. The member must present their own original monthly calendar with a pre-printed name and account number. No duplicates, reproductions or facsimiles will be accepted. A valid photo ID must also be presented to a Player Extras Club Representative to earn their entry. All entries must be deposited in the contest drum prior to 9 pm on the designated drawing date to be eligible. Limit one entry per Member.
- 5. Prize Drawing:** One winner will be randomly selected at 9:15 pm on the contest day. Winner need not be present to win.

6. **Prize:** The prize will be \$1,500 cash. If winner is present, additional prizes of \$510 cash and 1,000 Player Extras points will be awarded. The bonus 1,000 Player Extras points will not count towards VIP status.

Winner is responsible for all sales and income taxes. Valid identification must be presented prior to receiving prize.
