



**“CAMP OUT AND WIN”
OFFICIAL RULES**

(Updated 6/15/07 by Shannon Kingston)

1. **Eligibility:** This Contest is open to all active members of the Finger Lakes Gaming & Racetrack Player Extras Club, who are 18 years old or older, actively playing with their Player Extras Card inserted into a Video Gaming Machine, and who abide by the rules and regulations of the Player Extras Club. Employees of Finger Lakes Gaming & Racetrack and its subsidiaries and affiliates, people licensed by the New York State Division of the Lottery, and people licensed by the NY State Racing & Wagering Board as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies, and any immediate family members residing in the same household of any of the foregoing individuals are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.
2. **Sponsor:** (as defined below), Finger Lakes Gaming & Racetrack, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer online system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program; theft, tampering, destruction, or unauthorized access to, or alteration of applications; data processing that is processed late or incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. All entries become the property of the Sponsor and will not be returned. False and/or deceptive entries or acts shall render entrants ineligible.
3. **Contest Type:** Prize Drawing – must be present to win.
4. **Contest Period:** July 1-4, 2007

Method of Entry: Beginning at 12:00 p.m. July 1, Player Extras Members who check in at the Club during designated times will be automatically entered to win the Camp Out and Win package, including a tent, two sleeping bags, and a camp stove, valued at \$1,750 (or a \$1,000 cash alternative). There are 2 drawings each day. Members who check in between 12 p.m. and 4 p.m. will be eligible for the 4:15 p.m. drawing. Members who check in between 5 p.m. and 9 p.m. will be entered in the 9:15 p.m. drawing. Winning entry will be randomly drawn from the specially-marked Camp Out and Win prize drum. Must be present to win. If after 5 minutes the announced winner has not reported, another winner will be drawn. The prize drum is emptied after each drawing. Each package is valued at \$1,750 (\$1,000 cash alternative).

5. **Prizes:** The prize for each drawing: 4:15 p.m. and 9:15 p.m. each day is a camping package including: a tent, two (2) sleeping bags, a camp stove, a camp kitchen, a kayak with paddle and life vest, a canopy, portable table, two (2) table lamps, a lantern, a portable coffee maker,

queen-sized insta-bed, four (4) folding chairs, three (3) pans, flashlight set, and a cooler (total value of \$1,750). Cash option is \$1000.

6. **Prize Drawing:** A Player Extras Club representative will randomly select an entry ticket from the specially-marked drum. Winner must be present within 5 minutes of name being announced on the gaming floor. After the 5 minutes expire, a new name will be drawn and this process continues until a winner is declared. A total of eight (8) Camp out and Win packages will be awarded as prizes over the contest period.
7. **Prize Acceptance:** All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the winner to pay. Winner is responsible for all sales and income taxes. By accepting their prize, winner acknowledges any and all restrictions, expiration dates and liabilities. Winners may be required to complete, execute and return an Affidavit of Eligibility/ Release of Liability and (except where prohibited) a Publicity Release and a completed IRS W-9 form within 14 days of issuance.
