



“JACKPOT WINNER GIVEAWAY AND BONUS DRAWING”
OFFICIAL RULES
(Updated 10/21/10)

1. **Eligibility:** This drawing is open to all active members of the Finger Lakes Gaming & Racetrack Player Extras Club, who are 18 years old or older, and who abide by the rules and regulations of the Player Extras Club. Employees of Finger Lakes Gaming & Racetrack; its subsidiaries and affiliates; people key licensed by the New York State Division of the Lottery; people licensed by the NY State Racing & Wagering Board as on-the-grounds employees; vendors directly associated with this contest, their subsidiaries, affiliates and agencies; and any immediate family members residing in the same household of any of the foregoing individuals are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, consultant, officer; or employee of a contractor, subcontractor, licensee, registrant or consultant, that is directly involved in the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.
2. **Sponsor:** (as defined below), Finger Lakes Gaming & Racetrack, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer online system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program. Neither Finger Lakes Gaming & Racetrack, nor any of the aforementioned are responsible for theft, tampering, destruction, or unauthorized access to, or alteration of applications; data processing that is processed late, incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. False and/or deceptive entries or acts shall render entrants ineligible.
3. **Contest Type:** Drawing
4. **Contest Period:** Each Calendar Month in 2010 represents a different eligibility period.
5. **Method of Entry:** Player Extras Members who win a jackpot of \$600 or more during any month in the promotional period will be automatically entered into the Jackpot Bonus Drawing for \$1,000 cash on the first Tuesday of the following month. Members will receive one entry per jackpot won during the promotional period. To activate their entries, jackpot winners must play with their own Player Extras Card inserted into any video gaming machine between 10am-8pm on the day of the Bonus Drawing. Winner need not be present to win, but must activate their own entries by playing any video gaming machine with their own Player Extras Card inserted to become eligible. In addition, each jackpot winner who presents their Jackpot Winner Slip to Player Extras receives 25 points added into their Player Extras account for each jackpot won. The Cashier's Cage will issue a Jackpot Winner Slip to any patron presenting a limited voucher of \$600 or over. No duplicates, reproductions or facsimiles will be accepted. A valid photo ID must also be presented to a Player Extras Club Representative to receive entries.

6. **Prize Drawing:** One (1) winner will be selected at random at 9:00 pm on the first Tuesday of each month (except in cases during which it falls on a holiday and the drawing would be held on the first Wednesday), based on the previous month's eligible entries. Winner need not be present at drawing to win. Drawing is conducted using Finger Lakes Gaming & Racetrack's Virtual Drawing application. In addition, on the day of the drawing, any jackpot winner that checks in at the Club and one guest (who must also be a Player Extras Member) will receive a \$10 free play voucher. Limit one \$10 free play voucher per Player Extras Member. Jackpot winners may not receive an additional voucher by accompanying another winner as their guest. Furthermore, on the day of the drawing, any jackpot winner that checks in at the Club between 3pm-9pm will receive one entry to place in a barrel at Seven's Sports Bar. There will be twenty (20) random drawings at Seven's between 5pm-9pm for \$50 in free play. Winner must be present within five minutes of their name being called to win, or an alternate winner will be drawn. Management will determine winners' verification and club membership. The decision of Finger Lakes Gaming & Racetrack regarding the selection of winners and all other aspects of the contest shall be final and binding in all respects.

7. **Prizes:** On the day of the Bonus Drawing, one participating Jackpot Winner will receive \$1,000 cash if present. If the winner is not present, the prize is \$500 cash. All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the winner to pay. Winner is responsible for all sales and income taxes.

In addition, on the day of the Jackpot Winners' Party, each jackpot winner and their guest (who must be a Player Extras Member) will receive a \$10 free play voucher and there will be twenty (20) \$50 Free Play winners between 5pm-9pm at Seven's Sports bar on the day of the drawing. Only Jackpot Winners are eligible for the free play drawings. Winners must be present to win.

8. **Prize Acceptance:** All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the winner to pay. By accepting their prize, winners acknowledge any and all restrictions, expiration dates and liabilities. If winner does not claim prize within 60 days of drawing, an alternate winner will be selected. Winners will be required to complete, execute and return an Affidavit of Eligibility/ Release of Liability and (except where prohibited) a Publicity Release and a completed IRS W-9 form (when prize value exceeds \$600) to receive prize. Failure to return all required documents in this time period might result in the winner being disqualified and an alternate winner selected.
