



“\$50,000 SIZZLIN SUMMER RULES”
(Updated 7/15/10)

1. Eligibility: This promotion is open to all active members of the Finger Lakes Gaming & Racetrack Player Extras Club, who are 18 years old or older, and abide by the rules and regulations of the Player Extras Club. Employees of Finger Lakes Gaming & Racetrack; its subsidiaries and affiliates; people key licensed by the New York State Division of the Lottery; people licensed by the NY State Racing & Wagering Board as on-the-grounds employees; and vendors directly associated with this contest, their subsidiaries, affiliates and agencies; and any immediate family members residing in the same household of any of the foregoing individuals are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, consultant, officer; or employee of a contractor, subcontractor, licensee, registrant or consultant, that is directly involved in the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state, local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.

3. Promotional Period: Each Sunday through Saturday in August 2010 (August 1-28). The weekly promotional periods are as follows: August 1-7, 2010; August 8-14, 2010; August 15-21, 2010; August 22-28, 2010.

4. Method of Entry: Beginning at 10am on Sunday, August 1, Player Extras Members may earn entries for the 10 pm Saturday drawings by playing any video gaming machine with their own Player Extras Card inserted. Each Saturday, between 10am-9pm, Members must play with their own Player Extras Card to activate their entries and become eligible for the 10pm drawing. All entries earned will be eligible for each weekly drawing. Player Extras Members may earn one official entry by 1) playing any Video Gaming Machine with their own Player Extras Card actively inserted into the appropriate card slot and meeting the “cash played” threshold of \$50; 2) earning 10 entries by winning a jackpot of \$600 or more and presenting a Jackpot Receipt issued by the cashier to Player Extras; 3) redeeming a maximum of fifty (50) points per day in exchange for one entry per point. Note: Entries earned after 9pm on Saturdays each week in the promotion period will be eligible for the following week’s drawings.

Members can also receive multiple entries in the following ways:

A. Big Bonus Entry Days: Player Extras Members that earn five (5) base points on August 5, 13, and/or 16 will receive 25 bonus entries into the grand prize drawings. Receive 25 bonus entries for every 5 base points earned. All five base points must be earned the same gaming day by playing any video gaming machine with your Player Extras Card.

B. Club 55 Tuesdays: Player Extras Members (55+) who check into Player Extras on Tuesdays during the promotional period may earn 5X entries for that day's play.

C. Silver Members: All Silver Player Extras Members that play with their Player Extras Cards inserted into any video gaming machine between 10am-4pm on Saturdays during the promotion period will receive 3x entries for that day's play.

D. Gold Members: All Gold Player Extras Members will earn 2X entries every day during the promotional period that they play with their Player Extras Card inserted into any video gaming machine. In addition, all Gold Player Extras Members that play with their Player Extras Card between 10am-4pm on Saturdays will receive 4X entries.

E. Platinum Members: All Platinum Player Extras Members will earn 3X entries every day during the promotional period that they play with their Player Extras Card inserted into any video gaming machine. In addition, all Platinum Player Extras Members that play with their Player Extras Card between 10am-4pm on Saturdays will receive 5X entries.

F. Preferred Members: Player Extras Members who play with their Player Extras Card inserted into any video gaming machine between 10am-4pm on Saturdays will receive 2X entries for that day's play into that week's drawing.

On Tuesdays during the promotional period, Gold or Platinum Members that also belong to Club 55 will only be eligible for one of their benefits and cannot combine the 5x Club 55 entries with their Gold or Platinum benefit (8X entries, etc.).

5. Weekly Cash Prizes: Each Saturday in August (7, 14, 21, 28) there will be a grand prize drawing at 10pm. The following are the cash prizes to be awarded:

August 7 at 10pm: one \$2,500 winner; three \$500 winners

August 14 at 10pm: one \$5,000 winner; three \$500 winners

August 21 at 10pm: one \$7,500 winner; three \$500 winners

August 28 at 10pm: one \$10,000 winner; five \$500 winners

Winners need not be present to win, however if the winners are present they will receive a \$500 Be There Bonus.

6. Sizzlin Summer Weekly Drawings: Each Saturday in August there will be an escalating cash drawing. All Player Extras Members who played with their Player Extras Card inserted into any Video Gaming Machine in August are eligible for the Saturday drawings. Participants must play with their own Player Extras Card inserted into any Video Gaming Machine each Saturday in August between 10am-9pm to activate their entries and become eligible for the 10:00pm electronic drawings. Winners need not be present at drawing to win, however, if the winners are present they will receive a "Be There Bonus" of \$500.

The drawing will be conducted using the Electronic Quickdraw module of the Casino Marketplace player tracking system. All eligible entries are placed into a pool on the date of the drawing, and names will be randomly selected via the Quickdraw module. A final report illustrating all activity with the Electronic Quickdraw will be printed and kept on file in-house.

7. Prize Acceptance: All costs/expenses incurred in accordance with the prize awarded (if applicable) are the responsibility of the winner to pay.
