



**“VALENTINE’S DAY GIVEAWAYS & DRAWING”
OFFICIAL RULES**

1. **Eligibility:** This contest is open to all Members of the Finger Lakes Casino & Racetrack Player Extras Club, who are 18 years old or older, and who abide by the rules and regulations of the Player Extras Club. Employees of Finger Lakes Casino & Racetrack; its subsidiaries and affiliates; people key licensed by the New York State Division of the Lottery; people licensed by the NY State Racing & Wagering Board as on-the-grounds employees; vendors directly associated with this contest; their subsidiaries, affiliates and agencies; and any immediate family members residing in the same household of any of the foregoing individuals are ineligible to participate in the program. In addition, any member who checks in at Player Extras prior to 2am will receive one entry ticket into a drawing for \$1,500 worth of diamond jewelry from The Source (\$1000 cash alternative). Limit one entry per Member. No duplicates, reproductions, or facsimiles will be accepted. All entries must be deposited in the contest entry drum prior to 2am to be eligible for the drawing. Tickets must be deposited immediately after being issued and may not be taken from the facility and brought back at a later date or time for deposit into the drum. 5b. Mystery Free Play Valentine: The first 1,500 Members to check into Player Extras will also receive a Valentine which will reveal their mystery free play amount. Free Play valid on all video gaming machines. Free Play prize amounts are as follows:

\$5 \$10, \$15, \$20, \$25, \$30, \$40, \$50, \$75, \$100, \$150, \$250.

5c. Diamond Jewelry Drawing: There will be one \$1500 diamond prize from "The Source" Jewelers awarded (\$1000 cash alternative). The drawing will be held prior to opening the following day. Winner will be notified and need not be present for the drawing to win.
