



**NASCAR Weekend at Watkins Glen Promotion
OFFICIAL RULES
(Updated 5/15/07 by Mare Millow)**

- 1. Eligibility:** This Contest is open to all active members of the Finger Lakes Gaming & Racetrack Player Extras Club, who are 21 years old or older, and abide by the rules and regulations of the Player Extras Club. Employees of Finger Lakes Gaming & Racetrack and its subsidiaries and affiliates, people licensed by the New York State Division of the Lottery, and people licensed by the NY State Racing & Wagering Board as on-the-grounds employees, and vendors directly associated with this contest, their subsidiaries, affiliates and agencies, and any immediate family members residing in the same household of any of the foregoing individuals are ineligible to participate in the program. Any licensee, registrant, contractor, subcontractor, or consultant, or officer, or employee of a contractor, subcontractor, licensee, registrant or consultant, if such person is directly involved in the operation of video lottery gaming, the operation or observation of video lottery gaming or drawings, or the processing of video lottery gaming prize claims or payments is ineligible to participate in the program. All federal, state and local rules and regulations apply. Void where prohibited or restricted by law. By entering this contest, entrants agree to abide by all terms of these official rules.
- 2. Sponsor:** (as defined below), Finger Lakes Gaming & Racetrack, their respective affiliates, subsidiaries, parent corporations, and their respective officers, directors, shareholders, employees and agents are not responsible for any incorrect or inaccurate entry information; human error; technical malfunctions; failures, omission, interruption, deletion, or defect of any telephone network, computer online system, computer equipment, servers, providers, software or satellite transmission, including any injury or damage to participant or any other person relating to or resulting from participation in this program; theft, tampering, destruction, or unauthorized access to, or alteration of applications; data processing that is processed late or incorrectly or is incomplete or lost due to computer or electronic malfunction; printing or other errors; or any combination thereof. All entries become the property of the Sponsor and will not be returned. False and/or deceptive entries or acts shall render entrants ineligible.
- 3. Contest period:** Beginning 6pm-2am daily June 5 – 9pm July 6, 2007.
- 4. Method of Entry:** Beginning Tuesday, 6/5/07 and running through 9pm Friday, 7/6/07, Player Extras Club members, who are age 21 and over, who check in at the Player Extras Club after 6pm on any day, may receive one (1) daily entry ticket per day into the June 2007 Seven's Promotion drawing. Management must be able to determine contestants' identity, and a valid photo ID must be presented to receive prizes. The guest must receive the entry ticket at the Player Extras Club and place it into the barrel located at Seven's Sports Bar. Any entry ticket that is mutilated, altered, copied, hand printed, forged, water damaged, manipulated, or tampered with in any way, or which contains any computer programming, printing, mechanical or typographical errors, will be considered null and void and will not be eligible for prize redemption.
- 5. Prize Drawing:** The drawing will be held on July 6, 2007 at 9 p.m. A Player Extras Club representative will randomly select an entry ticket from the prize barrel. Winner must be present within 5 minutes of name being announced on the gaming floor or an alternate winner will be awarded the prize. To avoid delays if a potential winner is not present, 5 additional tickets will be drawn and announced in the order drawn, the first ticket having highest priority and the last ticket having lowest priority. If the first guest announced does not approach within 5

minutes, the next present guest wins, and any remaining alternates will receive nominal consolation prizes (provided by promotional vendor) of a value of no higher than 150 points or \$10.

6. **Prizes:** NASCAR Weekend at Watkins Glen Package (three-day race tickets for two, \$100 spending money, \$50 gas card, two hospitality tickets, and Budweiser racing apparel). Because this is a vendor-sponsored event, the actual prize awarded may vary from that described.
7. **Prize Acceptance:** By accepting the prize, winner acknowledges any and all restrictions, expiration dates and liabilities.
